BMW and a Class-Action Lawsuit

BMW Of North America has been hit with a proposed class-action lawsuit, alleging it sold thousands of motorcycles with defective gear indicators, posing a potential safety hazard.

The complaint was filed on behalf of plaintiff Daniel Casey. He claims the indicators intermittently displayed the wrong gear or didn't display any gear at all. Casey also claims that the faulty indicators have been the subject of many customer complaints.

The plaintiff alleges that because riders use gear readings to determine how to handle their motorcycle, inaccurate gear indicators can result in numerous problems. Casey has claimed that the defective gear indicator:

- impedes him from properly judging accelerating power and torque delivery;
- places the motorcycle in incorrect gear while on cruise control;
- reduces gas mileage;
- causes "excessive strain" on the motor among other things.

The gear indicator defect reportedly affects 2003-2019 F, K, G, R, HP2, and S series BMW motorcycles. Casey reportedly experienced the issue with his 2016 F700GS BMW. In 2017, a little over a year after purchasing the motorcycle brand new, Casey reportedly started to experience issues with his gear indicator where it would display the wrong gear or would not indicate a gear at all.

In his court filings, Casey says that BMW knew about the defective gear indicators as a result of

complaints that appear on BMW online forums as well as failures reported to dealers or the company itself.

The BMW motorcycle class action lawsuit seeks monetary damages, treble damages, punitive damages, court costs, and attorneys' fees.

The **BMW Motorcycle Gear Indicator Defect Class Action Lawsuit** is *Casey v. BMW of North America LLC*, Case No. 2:19-cv-14761, in the U.S. District Court for the District of New Jersey.

What do our members think? Is this a safety concern? Is BMW at fault? Should BMW pay for damages?

John Wesley Powell 150th Anniversary River Raft Trip Diane Krohn

(No, it's not a motorcycle trip – but it does have camping, adventure, and exploration of unknown parts! Several members asked me to do a write-up about our rafting adventure in June, so here goes...)

On May 24, 1869, nine men, led by John Wesley Powell, left Green River, Wyoming, for the purpose of exploring the Green and Colorado Rivers. On August 30, 1869, ninety-nine days later, Powell and five of his remaining men reached the confluence of the Colorado and Virgin Rivers in southern Utah. This was arguably one of the most epic explorations of the American West, perhaps second only to that of Lewis and Clark some six decades earlier.

To celebrate the 150th Anniversary of this historic event, the outfitter OARS organized a 28-day rafting trip to re-trace much of Powell's trip, the section between Flaming Gorge Dam in Utah, and Lake Powell, Utah. This section is the longest un-dammed section of the Green River and Colorado River. Wayne and I signed up for this trip, along with some long-time friends. All of us had rafted on the Colorado River in Grand Canyon two times previously (14-day trips), so we felt we could manage a 28-day trip on the river. The trip had 20 passengers and six guides; we had two dories and three rafts for passengers, and one baggage raft. The advantage of a guided trip such as this is that we did not have to worry about logistics, permits (of which many special permits were needed) or food planning and prep.

We were off on a very unique trip, as there were sections of the Green River that are not normally floated as commercial trips. And, because this was a unique trip, the guides were not sure about every campsite, or lunch stop, or the landing areas for the boats. Some of our landing spots required a certain amount of vegetation trimming and sometimes step construction in mud before we could even off-load the boats.

The dories each held one guide and 4 passengers, and the rafts were the same. The baggage raft just held more supplies but no passengers. The rafts are a more forgiving ride, due to the weight, size and, well, being inflated with air; the dories give a more "roller-coaster ride" and hit the water harder. Most days followed a similar pattern of getting onto the river at around 9 or 9:30 a.m., stopping for lunch, maybe going for a hike, and then stopping for a campsite. The guides prepare the meals,

which are delicious, healthy, and quite varied.

We had fresh fruit with breakfast every single day and usually fresh green salads at dinner. We re-supplied twice during the trip—which meant that we had ice cream for dessert each night after a re-supply!

We met in Vernal, UT for orientation, and then the next day we got into the boats at the Spillway Boat Ramp just below Flaming Gorge Dam. The water was at a very high level and was COLD (43 °F). On our second day on the river, we had one of our first challenges: a low bridge that had to be portaged. Due to the high river flow, we could not go under the bridge!

The water was deep and cold!

Lucky that there was a boat ramp just above the bridge and one below the bridge. All hands were needed to get the rafts and dories on and off the trailers. One of the rafts got punctured by a Zerk fitting on the trailer—requiring a complete off-loading of that raft, a puncture repair, and subsequent breath-holding as we put the raft back in the water and looked for bubbles or leaking. The patch held. Whew!

We continued on the way, floating through a number of beautiful canyons and areas: the Canyon of Lodore, Whirlpool Canyon, Dinosaur National Monument, Desolation Canyon, the

Uinta Basin, Labyrinth Canyon, Canyonlands National Park, Stillwater Canyon, and finally Cataract Canyon. We did not go through Grand Canyon on this trip as the river is dammed at Lake Powell/Glen Canyon Dam; Lake Powell was our take-out spot.

The boats were rowed by the guides most of the days, but there were sections of flat water; and between the flat water, headwinds, and the necessity of making a certain number of miles that day, there were a few times when the boats were all tied together and a motor was used to propel us down the river.

We hiked to petroglyphs and pictographs, ancient granaries, spectacular views and waterfalls. There were a couple of days with some rain but not all-day deluges. weather had started out on the chilly side, but as we got closer to the confluence of the Green and the Colorado Rivers, the weather got increasingly warmer. The river water warmed up to around 64 °F, making swimming and bathing reasonably comfortable -or, at least not as body-numbing as water temperatures in the 40's!

We saw some desert bighorn sheep, several groups of wild horses, a few snakes and toads, and many birds, including bald eagles, great blue herons, ravens, kingfishers, golden eagles, white pelicans, mergansers, Canada geese, and ospreys. Mosquitoes? Yes, but...it could have been worse. The very high water level and fast flow meant that mosquitoes were not as numerous as they could have been.

About 3 weeks into the trip, we stopped overnight in the town of Green River, UT, for a night in a hotel (hot showers!), a visit to the John Wesley Powell Museum, and a dinner at a local dive bar. It was a nice break from the river, and allowed for the second re-supply.

After we reached the confluence of the Green River and the Colorado River, we entered Cataract Canyon which has the biggest rapids of our trip, and, per the guides, some of the biggest rapids on any river in the western US. These were big waves, indeed – coming from all directions, some as tall as 9 feet. We all made it through the rapids successfully, but

not without some excitement—one raft got stuck in a scary eddy and one dory almost lost 2 passengers and the guide!

We finished up our trip after 457 river miles. We took out at the now-abandoned Hite Marina in Lake Powell. The final thrill to the trip was flying from Lake Powell back to Vernal in small planes (a Cessna Yukon and a Gipps Aero Air Van), which allowed us a scenic flight over the river and canyons. The flight took about an hour, covering what had taken us 28 days to float.
